The Rural Capital Workforce Board is pleased to announce that the maximum reimbursement rates will be increasing **effective October 1, 2024**. The Rural Capital Area maximum reimbursement rates for licensed child care centers, licensed child care homes and registered child care homes will increase in all age groups. **Please retain this letter for your records.** Listed below are the updated reimbursement rates based on age of child, provider type, and Texas Rising Star rating. Please note that the maximum reimbursement rate is only received if the center's published rate is greater than the maximum reimbursement rates.
